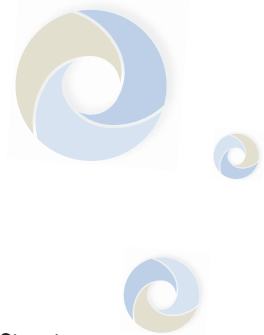

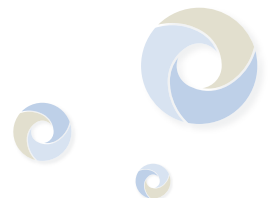

2014 Annual Meeting

MBR Annual Meeting Addresses Competitiveness, Marks Major Transition at the Roundtable

Vertex Pharmaceuticals President, CEO & Chairman Jeff Leiden, M.D., Ph.D., provided keynote remarks and hosted the Roundtable's 35th Annual Meeting at the company's world headquarters in Boston's Seaport Innovation District. Dr. Leiden remarked that Massachusetts, and the greater Boston area in particular, is a world-leader in innovation and he urged the members of the Roundtable to maintain this unique ecosystem on a national and global level. Members discussed ideas such as encouraging start-up companies to establish and grow in Massachusetts, taking steps to develop and retain top talent, providing financing throughout the life cycle of innovation, ensuring infrastructure keeps pace with growth, and robust and collaborative public-private partnerships.



Members attending the meeting also celebrated Donna Cupelo's remarkable and noteworthy four-year tenure as Chair of the Roundtable. Members expressed their gratitude to Donna for strengthening the organization and improving the value proposition for all members. The Board unanimously elected Michael Hogan, CEO, A.D. Makepeace Company, to serve as the new Chair and Marcy Reed, President, National Grid Massachusetts, as Vice Chair. Members also re-elected Treasurer, Irina Simmons, Chief Risk Officer, EMC and Secretary, Jeffrey Cook, Chairman, Cohen Kinne Valicenti Cook.



Fall Summits Convene Business Leaders and Public Officials to Address Talent

MBR-Sponsored STEM Summit Draws Record Crowds

In its 11th year, the statewide STEM Summit moved to Worcester's DCU Center and drew record crowds of close to 1,300 educators, business leaders, policy makers and students to advance the Commonwealth's nationally-renowned STEM agenda. STEM Advisory Council Co-Chairs, Vertex Chairman & CEO Jeffrey Leiden and Congressman Joseph Kennedy III, led the Summit and discussed ways to strengthen student interest and achievement in STEM throughout the state.

Sponsored by the Roundtable and 15 of its member companies, the STEM Summit addressed a wide range of areas

including employer needs, workforce development, state policy, computer science education and early childhood education. Roundtable Executive Director JD Chesloff moderated two panels on employer engagement featuring members from Verizon, EMC, General Dynamics, General Electric and National Grid that included State Senator Karen Spilka and State Representative Ann-Margaret Ferrante. MBR Chairman Michael Hogan and member Steve Vinter from Google provided closing remarks.



Education Survey of Business Leaders

MBR partnered with the Mass. Business Alliance for Education, MassINC Polling Group and Associated Industries of Massachusetts to conduct an employer opinion research survey regarding the state’s education system.

MassINC Polling Group surveyed nearly 400 businesses across the state, conducted focus groups of senior business executives and interviewed a group of prominent Massachusetts



CEOs. The results showed that Massachusetts business leaders think the state’s public school system is generally strong but that there was concern over how well schools are preparing students for careers. Sixty-nine percent of business leaders report some difficulty hiring Massachusetts employees with the right skills for open positions. And when they were asked what sorts of jobs they were have trouble filling, six of the top ten responses were in STEM fields.



Karen Kaplan Keynotes Northeastern Forum

The Northeastern University CEO Breakfast Series featured keynote remarks from Roundtable member Karen Kaplan, Chairman & CEO, Hill Holliday before a capacity crowd of business leaders in Boston. Ms. Kaplan presented a new model for building trusted connections and brands in the human era, where consumers want to do business with companies that view them and communicate with them as individuals. Consumers crave and reward authenticity and participation. Great brands embrace and cultivate an authentic experience and story.



Roundtable Members Participate in 5th Annual Jobs & Workforce Summit

Roundtable member Cathy Minehan, Dean of the School of Management at Simmons College, led a powerhouse panel on wage and gender equity that included State Street’s Kathy Horgan, Harvard Kennedy School’s Victoria Budson and state Labor & Workforce Development Secretary Rachel Kaprielian during the Jobs Summit at Devens. The Summit drew business, education and workforce professionals, as well as federal and state policy makers to highlight effective strategies for building the talent pipeline companies need to be successful in Massachusetts. Congressman Joseph Kennedy said, “Our people are our competitive advantage” and said that investing in workforce development is the best investment the state can make to strengthen the economy.

BOSTON 2024 Boston 2024 Olympics Bid

The Roundtable’s fall Board meeting hosted by MBR member Foley Hoag featured a timely discussion with Dan O’Connell, President of the Boston 2024 Partnership, regarding efforts to bring the 2024 Summer Olympics to Boston. Mr. O’Connell detailed the strengths of Boston’s proposal and discussed the importance of partnerships with leading universities, companies and public officials. Several Roundtable members including Karen Kaplan, Robert Popeo and others played key roles in developing Boston’s successful bid chosen by the US Olympic Committee to represent the country in the international competition to host the Games.

MBR Task Forces convene members to **generate** ideas and develop guiding principles, which informed the development of our “Framework for Long Term Competitiveness in the Commonwealth,” a collection of themes and policy recommendations to guide policy makers in improving Massachusetts’ competitiveness. 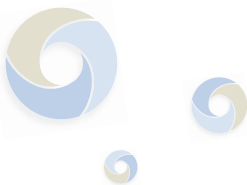

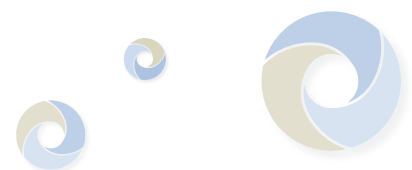
Implementing Ideas: Turning Ideas Into Action

Cost Competitiveness Outcomes in 2014

- ▲ **R&D Tax Credit:** Working with members and partners in the business community, MBR advocated for the state to modernize its research & development tax credit by creating an Alternative Simplified Credit. *Signed into law in August 2014.*
- ▲ **UI Rate Freeze:** MBR worked with other business organizations calling for a freeze of unemployment insurance rates, averting an automatic tax increase that would have cost employers up to \$500 million. The Roundtable's competitiveness principles highlight that Massachusetts has the second highest UI costs in the country. *Signed into law in April 2014.*
- ▲ **Wireless Innovation:** MBR joined a coalition urging the state to create a wireless innovation policy for Massachusetts to encourage wireless investment, innovation and technology deployment without the uncertainty of having old-style telephone regulation applied to tomorrow's technology. Without the new law, Massachusetts would have been the first state in ten years to regulate wireless. *Signed into law in August 2014.*
- ▲ **Non-Compete Agreements:** Following extensive outreach and education by MBR and other business groups, no changes were made to the current laws governing non-competition agreements. These agreements provide important protections for innovation, intellectual capital, R&D capacity, and patent creation.

Public Investment Outcomes 2014

- ▲ **STEM Advisory Council:** MBR convened and led a coalition that prompted the creation of the Governor's STEM Advisory Council by Executive Order. The FY15 State budget codified the STEM Advisory Council into law and provided \$1.5 million in funding. The Roundtable was specifically named in the legislation as a member of the Council.
- ▲ **Computer Science Education:** MBR worked with the MassTech Collaborative, Mass. Competitive Partnership and MassTLC to support the work of the Massachusetts Computing Attainment Network to expand access to computer science offerings and increase the number of qualified teachers in this field. *Signed into law in August 2014.*
- ▲ **Workforce Training:** Through a partnership with the Workforce Solutions Group, which includes representatives from labor, workforce and community-based organizations, the Roundtable continued to push for greater coordination and alignment within the state's workforce development system. The Workforce Competitiveness Trust Fund was recapitalized in 2014 to support regional training partnerships with employers.
- ▲ **Innovation Commercialization Seed Fund:** MBR advocated for a competitive grant program supporting research at public and private research universities through "proof of concept" grants that will help ensure that all regions of the state have the opportunity to capitalize on the economic benefits of university R&D. The state provided \$2 million for the Fund.



Roundtable Policy Priorities 2015

- ▲ **Energy Costs.** Support efforts to increase the supply of natural gas through increased pipeline capacity as a strategy to bring down costs.
- ▲ **Gateway Cities.** Engage with the Gateway Cities initiative and bring the expertise of MBR members to improve opportunity in the state's Gateway Cities.
- ▲ **Emergency Preparedness.** Join with FEMA and other business associations to prepare a report that explores opportunities to strengthen public policy and better prepare businesses—large and small, their employees and their communities for all types of emergencies and disasters.
- ▲ **STEM:** Prioritize STEM education through the STEM Pipeline Fund and STEM Starter Academy, and leadership on the STEM Advisory Council; and Support MassCAN initiative to make computer science available to all students in the Commonwealth.
- ▲ **Workforce Development:** Strengthen the alignment of the state's workforce development system to better meet employers' needs and promote existing resources available through the Workforce Competitiveness Trust Fund, Workforce Training Fund and the Hiring Incentive Training Grant Program.
- ▲ **Early Childhood.** Support early childhood education and advocate for important links between early childhood and STEM.
- ▲ **Adequate Investment in Infrastructure.** Continue to advocate for reforms, efficiencies and adequate funding for the state's infrastructure to ensure economic growth in every region of the Commonwealth.
- ▲ **Medicaid Reform.** Advocate for improved transparency in the Medicaid payment system to ensure efficiency and reduce cost shifting to private payers that results in higher premiums for employers.
- ▲ **Payment Reform.** Continue to urge state government to use its purchasing power to make payment reform within the Medicaid program an immediate priority in order to lower the cost of health insurance premiums for individuals and employers in Massachusetts.





Sharing Ideas: Collaborating with Decision Makers



Former Roundtable Member and New Governor Charlie Baker Addresses MBR

Former Roundtable member, CEO of Harvard Pilgrim Health Care and new Governor, Charlie Baker, met with Roundtable members twice in 2014, focusing on three broad categories: jobs, schools and communities. He highlighted the importance of public service and discussed a variety of issues including job creation, the high cost of energy, Medicaid reform, workforce development, regulatory reform and tax policy. MBR presented Governor Baker with the Framework for Long Term Competitiveness in the Commonwealth, which includes a shared vision and many shared priorities with the Baker Administration.

Joint Meeting of the Berkshire Business Roundtable and MBR

Berkshire Business Roundtable Chairman, long-time MBR member and CEO of Berkshire Bank Mike Daly Hosted a special joint meeting of the Roundtables in Pittsfield. More than three dozen business leaders and elected officials from industry sectors and areas spanning across the Commonwealth engaged former Governor Deval Patrick in a conversation on strengthening the state's regional economies.



Roundtable Hosts Policy Makers Conversations with House Speaker & Senate President

House Speaker Robert DeLeo participated in MBR's "Roundtable Policy Makers Series" by engaging with members on a range of timely issues. Speaker DeLeo listened to ideas and answered questions raised by members on housing, brownfields redevelopment, STEM education, municipal healthcare reforms and Gateway Cities. The Speaker highlighted his commitment to maintaining fiscal stability citing Massachusetts' strong bond rating and healthy stabilization fund. Speaker DeLeo thanked the Roundtable for working closely with the Legislature on major issues highlighting transportation and education as key examples.



Senate President Therese Murray covered a wide range of topics including job creation, health care cost containment, STEM education, life sciences, electronic health records, big data, workforce development, higher education, water/wastewater -long conversation with Roundtable business leaders. Senate President Murray thanked the Roundtable for its collaboration and leadership, and highlighted the state's efforts to attract companies from around the world to invest in Massachusetts.

Roundtable Launches New Website and Social Media

Boston Business Journal

Roundtable Chair and Vice Chair Donna Cupelo and Michael Hogan co-authored an op-ed piece that ran in the Boston Business Journal during MBR's annual meeting highlighting five core principles for the state to enhance its competitiveness in the global economy. It focused on reducing the costs of health care and energy, adopting policies that spur economic growth in the state's Gateway Cities and strengthening the talent pipeline, a major competitive advantage for Massachusetts.

“By choosing to directly fund computer science, Massachusetts is poised for national leadership both educationally and economically. And the business community is on board, offering to match state funding dollar-for-dollar to drive the expansion of professional development opportunities to teachers from Boston to the Berkshires with a full range of K-12 offerings, including elements for K-8 (crucial points for exposing students to computer science), and a new AP Computer Science Principles offering in high school.”

Roundtable Member Steve Vinter of Google and House Speaker Robert DeLeo co-authored an op-ed calling for the state to improve computer science education across the state through a partnership with the business community. It specifically highlighted the need to develop state computer science standards, a comprehensive computer science curriculum, and support teachers and districts willing to provide new computer science courses to students in Massachusetts. Legislation signed into law in 2014 provided \$1.5 million for the Massachusetts Computing Attainment Network, which was established through a coalition including Google, Microsoft, Mass. Business Roundtable, Mass. Tech Collaborative, Massachusetts Competitive Partnership, Mass. Tech Leadership Council, and others.

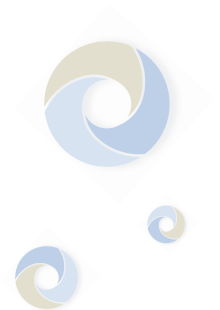
